The Terms and Conditions set out in this document relate to the competition being run and advertised by the below wedding suppliers, referred to as the 'Norfolk key worker wedding team' whom act together for the purpose of this competition form a 'not for profit' group.

The prize: An employed Key worker who is engaged and lives in Norfolk will win their wedding day as listed below.

There is no cash alternative to the prize offered and all individual suppliers may have their own T&Cs in place that will need to be agreed to.

Some additional charges may apply - these will be explained in detail below. No supplier named will be making a profit from any of the offers listed below.

The above suppliers will be referred to collectively as the 'Norfolk key worker wedding team'.

Conditions of Entry:

1. Both parties must be over the age of 18 and at least one person of the couple must have been a key worker who has been employed for at least 1 month prior to entry.
2. The key worker will be expected to provide proof of employment by means of photographic ID.
3. All of the suppliers involved are based in Norfolk and therefore any meetings, trials, fittings etc. will take place in Norfolk. It is the winning couple's responsibility to arrange travel and travel costs to the supplier's location.
4. The couple and their wedding guests must be willing to travel to Norfolk for the wedding which will take place at Thursford Garden Pavilion, Laurel Farm, The St, Fakenham, NR21 0AS.
- 5. The wedding will take place on Thursday 13th May 2021**
6. All suppliers have confirmed availability for the above date.
7. The wedding date cannot be changed.
8. Only 1 vote per couple will be counted.
9. You can nominate yourself & your partner or you and your partner can be nominated.
10. The prize is non-transferable and there is no cash alternative from any of the suppliers.
11. If additional requests are required by the couple, then these should be discussed with the relevant supplier directly at the time of the request and any additional cost associated with the request will be agreed directly between the couple and the supplier. Additional costs will be the sole responsibility of the couple and payment due direct to the supplier.
12. All professional images and videos taken by Tim Wood photography and A visual, along with any images taken by any of the Norfolk key worker wedding team may be used by all suppliers for advertising purposes across social media and individual websites/promotional material. By entering the competition, you consent to these images being used and publicised in magazines and possible news articles.
13. The cost of notice of marriage and wedding insurance etc. is not included in the prize and must be arranged and funded by the winning couple.
14. Any service not included by the Norfolk key worker wedding team will be provided at the winner's expense and must be reviewed by the Norfolk key worker wedding team before being agreed to, in order to prevent conflicts of interest.
- 15. The closing date of the competition is midnight on the 9th July 2020**
16. All applications will be reviewed by 3 selected judges in the Norfolk key worker wedding team. They will be voted on their story and shortlisted to the last 10. The Norfolk key worker wedding team will agree on a winner.
17. Due to the current isolation rules imposed by the government, The Norfolk key worker wedding team are unable to specify the date that the shortlist will be created, and subsequent winner drawn; however, it will be done as soon as practical once the restrictions have been lifted. All updates regarding this will be communicated on the website www.norfolkkeyworkerwedding.co.uk and across social media platforms.

18. The winning couple will be contacted via telephone and email, which is why we ask for this on your entry form. The winning couple may also be announced on social media; however, privacy is paramount and therefore your full names / contact details will not be published.
19. If the winning couple do not wish to accept the prize, they must inform the Norfolk key worker wedding team within 72 hours of being made aware of their win, this must be done in writing, via email to norfolkkeyworkerwed@outlook.com. So the suppliers are able to select a new winner.
20. If the winning couple decide to decline the prize within the 72 hours, they therefore forfeit any rights to any part of the prize and cannot change their mind later.
21. All the suppliers involved have invested their time into this competition, all of the suppliers named must therefore be used as individually described below and not be disregarded based on the individual taste of the winning couple.
22. It is suggested that all those entering the competition will follow all the Norfolk key worker wedding team on social media, however, this is not a requirement of entry.
23. The competition is in no way affiliated to any social media platforms, although advertised on Facebook and Instagram.

VENUE & ACCOMIDATION – Thursford Garden Pavilion

24. The wedding will take place at Thursford Garden Pavilion, Thursford, Fakenham, Norfolk, NR21 0AS.
25. The Winning Couple will receive exclusive use of the Thursford Garden Pavilion for their wedding ceremony and reception at no cost. This includes the use of tables and chairs for the ceremony and wedding breakfast.
26. Unless otherwise agreed prior to the Wedding, the Hire Period will be the fifteen hour period from 09:00am until midnight on Thursday 13th May 2021.
27. Thursford Garden Pavilion will provide a drinks package consisting of prosecco and sparkling elderflower for arrival drinks, 1 bottle of white and 1 bottle of red wine per table for the wedding breakfast and prosecco for toast drinks.
28. Thursford Garden Pavilion will provide a fully stocked and staffed bar. Please note this is not included within the prize and will need to be funded directly by the Winning Couple or as a paying bar by their guests.
29. The bar shall remain open until 23:30, and any music must finish at 00:00. Thursford Garden Pavilion requests that guests leave promptly after this time and respect the village by doing so quietly.
30. The Winning Couple are responsible for the Venue during the period of the Wedding. Any damage to the Premises or its contents (including fixtures, fittings, décor) incurred as a result of the acts, omissions or default on the part of the Winning Couple or their guests will result in a charge to remedy such damage.
31. The Winning Couple shall complete a Damage Deposit form using an authorised credit/ debit card, returning it to Thursford Garden Pavilion before the wedding day. The Damage Deposit form and the credit/ debit card details given are to cover the cost to Thursford Garden Pavilion of any damage caused to the Venue, its equipment, contents and fittings and following the resolution of any damage will be securely disposed of by Thursford Garden Pavilion following the Event.
32. The Winning Couple agree to comply with, and use their reasonable endeavours to ensure their guests comply with, all reasonable instruction given by Thursford Garden Pavilion intended to ensure the safety of property and/ or people at the Venue. Children must be supervised at all times when on the Premises.
33. Thursford Garden Pavilion reserves the right to stop any activity which it reasonably believes is likely to cause damage to the interior or exterior of the venue or to risk the safety of people at

the Venue. Thursford Garden Pavilion will not tolerate any abusive behaviour by guests to any other guests or members of staff. Thursford Garden Pavilion reserves the right to remove any persons acting inappropriately from the Wedding.

34. Smoking is not permitted on site, guests must use the designated smoking area located beside the main car park.
35. Unless Thursford Garden Pavilion expressly agrees otherwise, only food and drinks supplied by the Venue and the competitions Caterer may be consumed on the premises.
36. The Winning Couple agrees to confirm final guest numbers and details no later than 8 weeks prior to the Wedding so that Thursford Garden Pavilion may make the final arrangements.

ACCOMMODATION

37. Thursford Garden Pavilion are offering a complimentary two-night stay in Holly Lodge their boutique bed and breakfast for the newlyweds and 10 other guests. As well as a champagne breakfast for all guests on the morning of the newlywed's choice. (Weds 12th to Fri 14th May 2021).

CATERING – North Norfolk Catering Company

38. Back to your place will be providing Canapes, starter, main & desert for 70 people
39. Staff costs would need to be covered in full by the client at cost.
40. The hire costs would also need to be covered by the client but we will do a minimum of a 50% discount.
41. The winning couple will have a choice of three menus, the menus can be changed and supplement charges can be added to make the menu more bespoke for example – extra canapes, evening food.

EVENING CATERING – Back to your place

42. Back to your place will be supplying a Hog Roast for up to 120 evening guests
43. We will also be offering a 10% Norfolk Passport Discount to anything extra.

PHOTOGRAPHER – Tim Wood Photography

44. The winning couple will receive a full day coverage of their wedding by a single photographer from Tim Wood Photo.
45. After the wedding the couple will receive a keepsake box which will include a USB stick of all their photos, and some prints.
46. If any photobooks/albums are desired, these may be requested from Tim Wood Photo, however, will be subject to additional costs.
47. A second photographer may be added, but full payment of £400.00 will apply.
48. An engagement shoot may be booked prior to the wedding; however, it is not included within the prize and will require full payment of £500.00. Additional products may be purchased by the couple leading up to the wedding at an extra cost.
49. Tim Wood Photo retains the copyright of all images.

VIDEOGRAPHER – AVisuals

50. The winning couple will receive a full day coverage of their wedding by a single videographer from AVisuals.
51. AVisuals will finish shortly after the first dance in the evening.

- 52. After the wedding they will be provided with a highlight film usually 1 song long.
- 53. You will also be provided with a full film covering a separate film for full speeches also. Typically about 15 – 20 minutes long.
- 54. The finished film(s) will be delivered on a USB – Further copies available on request. (Charges on this may apply).

CEREMONY – The Ceremony People

- 55. The winning couple will receive a Wedding Celebration Ceremony conducted at Thursford Garden Pavilion by The Ceremony People. This will not be a legal ceremony and has no legal status.
- 56. The legal registration of the marriage can be completed in a Registration Office at the arrangement of the winning couple and is separate to the ceremony being conducted by The Ceremony People. The cost for this will be £46 plus £11 for the marriage certificate and is payable to the registration service at the time of booking.
- 57. An initial meeting to discuss ceremony choices and options, at the venue or an agreed location
- 58. Draft Ceremony content
- 59. Unlimited access via email, phone, text, skype etc.
- 60. Liaison with the venue and any other suppliers, as necessary
- 61. Rehearsal at the venue, if required
- 62. Delivery of the ceremony at Thursford Garden Pavillion on 13th May 2021

FLORAL DESIGN – Charlotte Staff Flowers

- 63. The winning couple will receive a bridal bouquet, grooms buttonhole, father of the bride buttonhole and top table or floral installation at the venue, up to the retail value of £500, inclusive of delivery (within a 60 mile radius of Caister on Sea) and set-up of flowers at the venue
- 64. The design process will be completely bespoke and individual to the winning couple; therefore, they will receive an initial consultation whereby the style, variety & seasonability of flowers will be discussed
- 65. Additional floral arrangements can be added if the winning couple so wish at cost price
- 66. All Flower choices and delivery arrangements made with Charlotte are to be confirmed & finalised by 2 calendar months before the wedding date
- 67. I aim to stick to the flower choices made in the initial consultation as closely as possible, but occasionally substitutions can occur due to wholesale availability. If this were the case the substituted flowers would be as close to the original selection as possible and still in keeping within the design
- 68. I strive to always provide the highest quality flowers and strictly the design brief. If however you felt this wasn't the case any complaints must be made on delivery of the flowers so that I can try to rectify any problems to as best my ability.

FLORAL DESIGN – Fern Flowers

- 69. Fern Flowers will be providing one Bridal bouquet and one Groom buttonhole in flowers and colours of the winner couples choice, up to the amount of £65 (Bouquet) and £8 (Buttonhole). This will also include delivery on the morning of the wedding day.
- 70. These can not be exchanged for money, vouchers, or other flower items from Fern Flowers. Fern Flowers will provide T&Cs to the winning couple with more details regarding their wedding day.

CAKE – Beth Haxby Cakes

71. The winning couple will receive a three tier semi naked cake; this includes the delivery and set up of the cake at the venue and will be enough for seventy guests.
72. Any flowers requested for decor will be provided by the wedding florist and will be included within the purchase of the flowers.
73. The winning couple will have the option to add buttercream icing and additional portions of cake at a cost to them.
74. Consultations will be subject to availability.

HAIRSTYLIST – Hair by Sophie Willis

75. The Bride will receive a mini hair trial prior to the wedding, which will take place at 'Cuttin It Hair & Beauty', 39 Bells Road, Gorleston-On-Sea, Great Yarmouth, NR31 6AN.
76. On the day of the wedding, the bride will receive the desired hair style with materials included i.e pins and styling products.
77. Hair By Sophie Willis can provide the service for bridesmaids and additional persons, however, charges will apply.

MAKE UP – Leanna Stibbon MUA

78. The Bride will receive a bridal makeup trial prior to the wedding, along with the chosen make-up design service on the day of the wedding, this includes use of make-up products and application.
79. Leanna Stibbon Makeup can provide the service for bridesmaids and additional persons; however, charges will apply.
80. The makeup consultation date will be subject to availability.
81. The consultation and bridal trial will be held at Leannas home studio at 27 Whiley Lane, Stalham, NR12 9FJ.
82. Travel for the make-up artist to the wedding venue is included within Norfolk.
83. Any images of the client taken by the artist at the event belong to the artist and permission is granted for these to be posted on social media sites, website and marketing materials as required.
84. The client is required to inform the makeup artist of any allergies and sensitivities to makeup and products of any and by all the clients prior to the application of makeup. No warranties are made by the artist and the artist shall not be liable for any direct and consequential damages arising out of the performance of service under this agreement.
85. Client hereby agrees to indemnify artist for any loss or damage to the artist, its personnel and equipment at the event site, provided the loss or damage was caused by person other than the artist.
86. 9.Those persons who are included in this contract are guaranteed services and if time allows additional clients can be added, on or before the event date for an additional fee. Additional services carried out on the event date are to be paid on the event date in the form of cash.

TREATMENTS – Norwich Face and Body Clinic

87. The Bride will receive three facials of her choice in the run-up to the wedding.
88. The Bride will receive two Cryolipolysis Targeted fat Freezes. A full consultation will be necessary to ensure the winner is medically suitable for the treatment.

89. The Bride will receive an Eyelash Lift or set of Classic eyelash extensions, advised 3-5 days before the wedding date.
90. A consultation and patch test will be required before commencing any of the treatment above. This will be held in Norwich at Norwich Face and Body Clinic.
91. All appointments must be booked one month in advance.
92. If the appointment is cancelled within 48 hours or failed the appointment be lost.
93. These treatments must be used by the winner only and not gifted.
94. Treatments must be redeemed before the wedding.

BRIDAL NAILS – HK Nails

95. The Bride will receive a full set of nails, of her choice.
96. A brief chat will be had to discuss preferences in order to ensure correct products are available prior to appointment.
97. Nail appointment will take place no more than 4 days prior to wedding.
98. The nail appointment booking needs to be made 8 weeks in advance in order to secure preferred date, as availability is often limited.
99. Cancellation may result in the appointment being lost, if there is no other suitable appointment available.
100. Nail appointment must be used by the winner only and not gifted.

BRIDAL DRESS – Adella Bridal

101. The bride can select a dress up to the value of £1500.
102. If a more expensive dress is selected, the additional value of that dress must be paid for by the winning couple.
103. A bridal consultation / fitting appointment is included in this prize.
104. If a second bridal dress is required, any additional dress would be subject to full payment.

BRIDAL DRESS ALTERATIONS - Little Miss Sew & Sew

105. will offer alterations up to the value of £150 + gown storage and steam for a gown provided by Adella Bridal.
106. Additional work not covered by this sum must be paid for by the winning couple.
107. Full terms will be provided prior to the first appointment which must take place no later than 8 weeks before the wedding date.
108. Appointments are subject to availability and on a first come first served basis so early booking is advised.

BRIDESMAIDS DRESS(ES) – Azalea Bridal

109. The winning couple will receive up to 4 multiway dresses with the choice of any colour from the range. If any additional dresses are needed then they will be available to purchase with a 50% reduction.
110. The dresses can be made for any size including custom lengths for all.
111. Final measurements must be received no later than 6 weeks prior to the wedding date.

112. Bridesmaids will not have to learn how to tie as our stylist will be able to come on the morning of the wedding to dress the bridesmaids.

BRIDAL VEIL – Pure Brides

113. The winning couple will receive a veil from Pure Brides in Norwich, up to the value of £195.00.

114. If a more expensive veil is selected then the difference must be paid for by the winning couple upon ordering.

115. The veil can be chosen from any of those sold in store.

116. No refunds/exchange/or cash alternative is available.

BRIDAL ACCESSORIES – Le Jour Bridal

117. The winning couple will receive a piece or pieces from Ivory & Co or Athena Bridal Jewellery, up to the value of £250.00 for bride and bridesmaid(s).

118. If the full amount is not used no cash refunds will be made.

119. One bridal consultation will be included within the prize if required.

120. No refunds/exchanges will be available after the item(s) have been ordered.

121. Additional products are available for purchase at their usual cost.

GROOMSWEAR – Moss Bros.

122. The winning couple will receive the hire of 4 suits; for example, the Groom, best man, father of the Bride and father of the Groom. Any additional members in the party will be charged at our normal fee rate.

123. The suits must be picked up and returned to Moss Bros within the specified and agreed timescale.

124. A security deposit will be to be paid on pick up and will be given back once the suits are returned and inspected, this is to cover any damages. Dry cleaning is covered by Moss Bros when the suits are returned.

125. If a same sex couple win the competition, the 4 suits remain available and may be supplied accordingly.

PERSONALISED GIFT BAGS FOR BRIDE & BRIDESMAIDS – Collection 1994

126. The winning couple will receive a personalised bridal gift set for the bride and 5 bridesmaids
This will include gift items inside.

127. The colour, font, wording can be personalised.

128. All orders must be placed no later than 4 weeks prior to the wedding.

129. A consultation can be arranged if required

CHAUFFEUR – Norfolk Classic Car Hire

1. The winning couple will receive hire of 1 car to travel to their wedding venue, chauffeur driven by Norfolk Classic Car Hire. The car will be dressed in the winning couples preferred colour scheme.
2. Pick up MUST be within 25 miles of the venue. If not charges may apply.
3. Once at the venue the car will be presented for the bride and groom to have their photos taken with the car.
4. The winning couple can select ANY one of our fleet to travel in at no addition cost (subject to availability).

5. Any additional requirements may be discussed with Norfolk Classic Car Hire (for example additional cars, additional trips).
6. The car is only for bride and groom.
7. The driver has the right to refuse any person to enter the car.

STATIONERY – The Luxe Paper & Co.

130. The Luxe Paper Co. will offer their bespoke design services fee for free which usually costs £300.00. And offer 50x Invitations, 50x RSVP cards and 50x Details cards
131. All digitally printed on 300gsm cardstock.
132. Any additional quantities, finishes or products will incur additional costs.

STATIONERY – Mel Made Stationery

133. The winning couple will receive Menus and Table Numbers/Names - one for each table
134. The winning couple will receive Placecards - one for each guest. Each placecard will have guests names printed. Names will need to be typed out and sent to Melmade 6 weeks before the wedding day.
135. The winning couple will receive 5 x A6 personalised 'Bridal Party' Thank you cards.
136. All stationery will be print only onto a 350gsm matt card, other stocks and finishes are available and can be discussed but could incur a cost.
137. Additional products can be requested, however usual costs will apply.

ROOM DÉCOR – Prestige Weddings and Events

138. A package of £800 will be supplied of the couples choice
139. The period of 'drop off hire items' is generally between 24 and 72 hours. We can be flexible on this at our own discretion. We will always try our best to complete drop offs and collections at a convenient and agreed time however we reserve the right to collect our hire items at midnight or early morning after your event as products may be needed for re-hire and will require a quick turnaround check over, clean and delivery – under these circumstances the collection time is non-negotiable.
140. Items in your care shall remain your responsibly at all times.
141. When items are returned badly damaged or broken in any way we have the right to charge you the replacement cost or treatment charge.
142. The replacement costs of all loses will be discussed and details of these charges will be available upon request. Substitute items will not be accepted and all damaged items remain the property of Prestige Events and Weddings.
143. Flower walls are for indoor use ONLY unless this has already been discussed and agreed with us.
144. Flower walls cannot be moved once installed due to safety regulations unless already discussed with us and we have agreed to come back to your venue to move or have discussed this with your wedding planner. If it has been agreed for your wedding planner / venue to move the flower wall and it gets broken or damaged this is your (the hirer) responsibility.
145. The hirer shall be solely responsible for the hire good. Hotels/venues/ florists/wedding planners or any other third party involvement will be exempt from any responsibility regarding hired goods and will not be held accountable should any damages occur whilst in their possession.

ROOM DÉCOR – Same Race Venue Decoration

- 146. Ceiling decor consists of A warm fairy light canopy and optional lantern install over the dance floor area. The lighting will extend to a top table light curtain
- 147. The lantern canopy will be of a multisize design and using colours from our stock.
- 148. The lantern canopy is optional but can not be replaced with other hanging items due to weight on the canopy ceiling, strength of the recommended clips used and preparation time.
- 149. We do not hang Pom poms.
- 150. Install and breakdown is included and timings will be arranged with the venue.
- 151. In the event of any breakages, damages will be charged at the replacement price from the original supplier in the first instance or on a cost/item like for like basis.

DJ – Paul Allen Wedding Services

- 152. The winning couple will receive the hire of Paul Allen Wedding Services – Evening DJ Service
- 153. Set up of all sound and lighting equipment prior to the start of the evening reception
- 154. Professional DJ equipment and sound system to suit venue
- 155. DJ to play background music during the arrival of evening guests before the first dance and performing up until 12am (where the license of the venue permits)
- 156. A pair of dance floor effect lights and a wash of colour behind the DJ.
- 157. Includes consultations via phone / WhatsApp.
- 158. Full terms and conditions of booking our service available on request
- 159. Rental agreement to secure services for winning couple will be required to be signed.

SINGER – Barny Holmes

- 160. The winner will receive a 2x 45 minute set by Barny Holmes.
- 161. Sound check will be required before the performance.
- 162. First dance/walk down the Isle music can be provided if requested, this may occur extra costs.

PIANIST – Carrie O'Donnell Wedding & Event Pianist

- 163. The couple will receive live performance of beautiful piano music during one section of the day, out of the following options:
- 164. The Ceremony includes 30 minutes as guests arrive, procession, signing of registers and recession or Wedding Breakfast - throughout the wedding breakfast.
- 165. Includes all travel costs, all rehearsal, consultation time, and any equipment hire, including sound system.
- 166. The music played will be a mixture of beautiful background romantic music with some bespoke choices from the winning couple; we will undertake a meeting either in person or via online whereby their individual music choices will be discussed
- 167. My baby grand piano shell will be included (worth £75)
- 168. All music choices are to be confirmed to Carrie & finalised at least three calendar months before the wedding date.

PHOTOBOOTH & LOVE LETTERS – Capture Lounge

- 169. Capture Lounge will provide the photo booth, love letters, table plan and welcome sign for the winning couple, other items can be selected or replaced if couple decides on another capture lounge product.
- 170. Capture Lounge will just require confirmation on items and designs 2 months before wedding date.

171. The winning couple are solely responsible for the items throughout the hire period and any damages / loss will be charged as per our terms and conditions which will be sent to the winner via email.

MAGICIAN – Tyler Harrison Magician

172. The winning couple will receive a two hour close-up magic performance from 'Tyler Harrison Magician'

173. The performance will take place during the drinks reception after the wedding ceremony and before the wedding breakfast starts

174. Should the client wish to extend the length of the performance beyond two hours, a fee will be charged as agreed between the parties.

GLITTER BAR – Face n Glitz

175. The winning couple will receive a 2 hour 'Glitz' package from Face 'n' Glitz with 2 x Glitter Artists (with a choice of Rustic or Rose Gold Glitter Bar) subject to availability.

176. The winning couple will have the option to upgrade to our 3 hour 'Full Shebang' option at an additional cost.

CHOCOLATE FAVOURS – Sweet Boutique

177. Sweet Boutique event planner of all occasions will be providing our candy cart package to the value of £350.00 and decorated with choice of colour scheme of the bride and groom. Also the donut wall package and donut stackers to the value of £250.00. Sweet boutique event planner for all occasions will provide a consultation with the bride & groom prior to their wedding date.

178. This also includes delivery, set up on the morning of the wedding day. These can not be exchanged for money, vouchers, or other items from Sweet boutique event planner of all occasions.

179. Sweet boutique event planner of all occasions will provide T&Cs to the winning couple with more details regarding their wedding day.

GN FAVOURS – St Giles Gin

180. St Giles Gin will gift 60 x 50ml bottles to be used on their wedding day. These will be sent to the venue or the winning couple to use for their guests on tables etc.

181. Any extra bottles will need to be paid for.

ADDITIONAL INFORMATION EXCLUSIVITY

182. It is understood that the Norfolk key worker wedding team will act as the sole and exclusive suppliers for your wedding with regards to their individual service. By agreeing to this contract, the winning couple agrees that no other person, company, professional or otherwise, shall provide products or services for the wedding without the consent of the Norfolk key worker wedding team. For example, if additional make up services are required, it is understood that Leanna Stibbon makeup will provide the entire service and all Flowers will be provided by Fern flowers and Charlotte Staff Flowers.

183. This clause is to protect the image of the above suppliers from assumptions that might occur from the event's attendees.

LIABILITY

184. None of the Norfolk key worker wedding team will be held responsible for injury, loss or damage to persons or property howsoever caused arising from any goods under hire or services provided.
185. Nothing in these Terms and Conditions is intended to or will exclude or limit our liability for death or personal injury caused by the Norfolk key worker wedding team's negligence.
186. All suppliers of the Norfolk key worker wedding team hold their own insurance, individual and specified to their business. If you wish to discuss any specific concerns, please speak to the individual supplier to see a copy of their insurance policy.

UNFORESEEN CIRCUMSTANCES (FORCE MAJEURE) & CANCELLATION

187. Whilst all suppliers will make every effort to ensure that the service agreed between the above-named suppliers and the winning couple is fully operational and error-free, we cannot guarantee this. Acts of God, events beyond our reasonable control, sudden ill health and adverse weather conditions may affect our ability to deliver the product or service. However, in cases of adverse weather we will remain in contact with the event commissioner in the lead up to the event. we cannot accept responsibility for Acts of God (Force majeure) sudden ill health, adverse weather conditions or any event beyond our reasonable control. And/if any of the Norfolk key worker wedding team are prevented from providing the service or product as agreed then they cannot be held accountable, however, agree to do all possible to find a replacement.
188. If an event is due to held be outside, but a sudden change in weather prevent this from occurring, or do not allow a named supplier to provide the set up agreed in service, then the service may have to be moved inside if applicable, no action can be taken against the suppliers in this circumstance.
189. A force majeure event includes any act, event, non-occurrence, omission or accident beyond our reasonable control and includes, in particular (without limitation), the following:
 - (a) strikes, lock-outs or other industrial action; or
 190. (b) civil commotion, riot, invasion, terrorist attack or threat of terrorist attack, war (whether declared or not) or threat or preparation for war; or
 - (c) fire, explosion, storm, flood, earthquake, subsidence, epidemic, pandemic or other natural disaster; or
 - (d) impossibility of the use of railways, shipping, aircraft, motor transport or other means of public or private transport; or
 - (e) impossibility of the use of public or private telecommunications networks.
191. Our obligations under these Terms will be suspended when the event occurs and for the period that the Force Majeure Event continues, and we will notify you as soon as is reasonably possible. Any time limits that we are bound by will be extended accordingly. We will inform you when that event is over and extend the time to perform these obligations for the duration of that period. We will take reasonable steps to bring the Force Majeure Event to a close or to find a solution by which our obligations under these Terms can be performed despite the Force Majeure Event.
192. If the winning couple decide to cancel the wedding then any fees already paid by the Norfolk key worker wedding team for cost of products etc, may be collected by suppliers, to ensure that no supplier(s) suffer a loss.
193. In the event that the government takes steps to restrict the movement or assembly of people due to any communicable illness, infection or other condition of any kind, our first priority must be public health and safety. Therefore, the Norfolk key worker wedding team will not be able to attend your event, if to do so would put us in violation of government issued advice or orders which could invalidate the insurance held. In the event of a postponement of the wedding (only

due to restrictions issued by the government) the Norfolk key worker wedding team will endeavor to change your date of booking where possible to your alternative date. An alternative date cannot be guaranteed and where this cannot be achieved where reasonable steps have been undertaken, the suppliers unable to provide services are indemnified from any claims and all financial responsibility arising for further cost incurred as a result.

194. If any party of this agreement is advised or instructed to self-isolate due any communicable illness, infection or other condition of any kind then the above conditions apply.
195. It is the responsibility of the winning couple to inform the Norfolk key worker wedding team if any party of this agreement and/or guest at their event has been informed to self-isolate so appropriate consideration can be taken on how to proceed accordingly.
196. Any supplier involved reserves the right to withdraw services up to the point of confirmation by the signing of a contract with that supplier. The terms above apply to the competition entry only and any further conditions, specific to the supplier, must be met before their services and inclusion in the event are confirmed. That contract will be binding on both parties as per the conditions of that contract.
197. The Norfolk key worker wedding team reserve the right to extend or modify the closing date at our discretion or modify the terms as appropriate at any time as other vendors offer services or circumstances change.

PRIVACY

198. Our entry form is managed by Amelia Hacking who only has access to the entry form details, however if you have been shortlisted, your information will be shared with 2 other suppliers from the Norfolk key worker wedding team to help chose a winner.
199. Your details will not be shared to anyone outside of the Norfolk key worker wedding team and will be security and password protected in line with GDPR policies.
200. All personal information that we may use will be collected, processed and held in accordance with the provisions of EU Regulation 2016/679 General Data Protection Regulation (“GDPR”) an your rights under the GDPR.

CHANGES TO TERMS AND CONDITIONS

201. We may from time to time change these Terms and Conditions without giving you notice but we will use our reasonable endeavours to inform you as soon as is reasonably possible of any such change.

SEVERANCE

202. If any provision of these Terms and Conditions is held by any competent authority to be invalid or unenforceable in whole or in part the validity of the other provisions of these Terms and Conditions and the remainder of the provision in question shall not be affected,.

LAW AND JURISDICTION

203. These Terms and Conditions, the Contract and the relationship between you and the Norfolk key worker wedding team whether contractual or otherwise shall be governed by and construed in accordance with the law of England and Wales. Any dispute, controversy or claim shall be subject to the jurisdiction of the courts of England and Wales.
